Sub: Regarding delegation of certain powers of Coal Controller under the Colliery Control Rules, 2004 to State Government – reg.

Ref: 1. Gazette Notification S. O. 645 (E) dated 02.03.2016 2. MoC's Letter vide No. 12012/1/2014-CA-II dated 11th march, 2016.

Sir/Madam,

I am directed to inform that vide Gazette Notification S. O. 645 (E) dated 02.03.2016 Central Government directed that the powers of Coal Controller under subrule (3), (4), (5) of Rule 4, Rules 5, 7, 10 and 12 of the Colliery Control Rules, 2004 shall be exercised by the respective State Governments or such officer as authorized by it through notification in respect of all coal mines except the mines or blocks of Central Government Public Sector Undertakings.

After a lapse of four years, no action has been taken by respective State Governments to exercise the above said power. As the project proponents of the coal/ lignite mines of State PSUs and Private mines approached CCO for grade approval, CCO has exercised that power under the similar provisions under the Coal Mines (Conservation and Development) Amendment Rules, 2011.

I am directed to inform that concerned departments of the State Governments shall notify accordingly to exercise the powers as provided in Gazette Notification S. O. 645 (E) dated 02.03.2016. In exercise of the powers conferred under sub-rule 1 of rule 4 of the Colliery Control Rules, 2004, Coal Controller laid down the SOP and LAID DOWN PROCEDURE and method of sampling & analysis of coal for the purpose of declaration and maintenance of grades of coal mined in a colliery for 2021-22 is already available in the website of CCO (coalcontroller.gov.in). For any guidance in this regard, CCO Regional offices will provide necessary training. State Government may take the services of Govt. Technical Institutions / Govt. Organizations for sampling and analysis of coal as per Laid down Procedure.
