Vacancy Circular

Applications 'through proper channel' are invited from eligible candidates for filling up the following posts on Deputation/ Re-employment basis:

(I) Category No.:1- Upper Division Clerk (Deputation basis)

- (a) No. of vacant posts: 4 (four)
- (b) Pay Level (Corresponding to Pay Band & GP: PB-1, 5200-20200+ GP-2400)
- (c) Place of Posting: Kolkata (3 Posts)
Dhanbad (1 Post)
- (d) Normal Tenure of Deputation: 3 years
- (e) Eligibility Criteria: Officers of the Central Government
 - (i) Holding analogous posts on regular basis in the parent cadre or

department;

OR

(ii) With 8 (eight) years regular service rendered after appointment to the post of Lower Division Clerk on regular basis in Pay Band-I, 5200-20200 with Grade Pay of Rs. 1900/- or equivalent in the parent cadre or department.

Note 1: The Departmental Officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, the candidates on deputation shall not be eligible for consideration for appointment by promotion (Period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organisation or department of the Central Government shall ordinarily not exceed three years). The maximum age limit for appointment by deputation shall not exceed 56 (fifty six) years as on the closing date of receipt of applications.

Note 2: For the purpose of appointment on deputation basis, the service rendered on a regular basis by an officer prior to 1st January 2006 (the date from which the revised pay structure of the Sixth Central Pay Commission recommendations has been extended) shall be deemed to be service rendered in the corresponding Grade Pay or Pay Scale extended, based on the recommendations of the Pay Commission except where there has been merger of more than one pre-revised scale of pay into one grade with a common Grade Pay or Pay Scale and where this benefit will extend only for the post or posts for which that Grade Pay or Pay Scale is the normal replacement grade without any upgradation.

- (b) Pay Level (Corresponding to Pay Band & GP: PB-1, 5200-20200+ GP-2400)
- (c) Place of Posting: Kolkata
- (d) Normal tenure of deputation: 3 years
- (e) Eligibility Criteria: Officers of the Central Government

(i) Holding analogous posts on regular basis in the parent cadre or department;

OR

(ii) With 8 (eight) years regular service in Pay Band-I, 5200-20200 with Grade Pay of Rs. 1900/- in the parent cadre or department.

- (d) Normal tenure of deputation: 3 years
- (e) Eligibility Criteria:

For Deputation: From amongst regular Dispatch Riders (Group C) and Group C employees in Pay Band 1, Rs. 5200-20,200 with Grade Pay of Rs. 1800 in the Coal Controller's Organisation who possess valid Driving License for Motor Cars on the basis of a driving test to assess the competence to drive Motor Cars failing which from officials holding the post of Dispatch Rider on regular basis or regular 'Group C' employees in the Pay Band 1, Rs. 5200-20200+Grade Pay of Rs. 1800 in other Ministries or Departments of the Central Government who fulfill the necessary qualifications as follows:

Essential:

- (I)** Possessing a valid driving license for motor cars;
- (II)** Knowledge of motor mechanism (The candidates should be able to remove minor defects in vehicles);
- (III)** Experience of driving motor cars for at least 3 (three) years; and
- (IV)** Pass in 10th standard from a recognized Board

Desirable:

Three years service as Home Guard or Civil Volunteer

For Deputation or Re-employment for Armed Forces Personnel: The Armed forces Personnel due to retire or who are to be transferred to reserve within a period of 1 (one) year and having the requisite experience and qualifications prescribed, shall also be considered. Such persons would

be given deputation terms up to the date on which they are due to be released from the Armed Forces, thereafter they may be continued on re-employment.

Note: The period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organisation or department of the Central Government shall ordinarily not exceed (3) three years. The maximum age limit for appointment by deputation or absorption shall not exceed 56 (fifty six) years as on the closing date of receipt of applications.

The application duly filled in as per Proforma at Annexure-I (Curriculum Vitae Proforma) along with the attested copies of ACRS/ APARS for the last 5 years, Vigilance Clearance Certificate and Integrity Certificate of the eligible candidates may be forwarded by the concerned Organization/ Department to Shri S. Masood, Deputy Assistant Coal Controller (Admn), Office of the Coal Controller, 1, Council House Street, Kolkata 700001 within 60 (sixty) days from the date of publication of the circular/advertisement.

Terms & Conditions of Deputation will be regulated as per DOPT's OM No. 6/8/2009-estt. (Pay-II) dt. 17/06/2010 as amended from time to time and for re-employed Armed Forces Personnel, it will be governed by the Central Government rules as applicable in case of re-employment in Central Government service.

The application(s)/CV not accompanied by supporting certificates/documents in support of Qualification and Experience claimed by the candidates would not be processed for determining the eligibility of the candidates for the selection.
