Notice

The undersigned is directed to say that BCCL, had submitted Progressive Mine Closure Monitoring and Audit reports of the First Phase conducted by IEST, Shibpur regarding reimbursement of claim under progressive Mine closure Plan of 03 Mines of BCCL as mentioned in Annexure -I for an amount of **Rs. 9,25,66,332/- (Nine Crore Twenty-Five Lakh Sixty-Six Thousand Three Hundred and Thirty-Two Rupees only)**. After scrutiny of document submitted by BCCL and inspection report submitted by OSD, CCO, Dhanbad, the Technical Committee of CCO (HQ), had recommended for reimbursement of **Rs. 7,53,55,892/- (Seven Crore Fifty-Three Lakh Fifty-Five Thousand Eight Hundred and Ninety-Two Rupees only)** for the said project. An Amount of **Rs.4,62,83,166/-(Four Crore Sixty-Two Lakh Eighty-Three Thousand One Hundred and Sixty-Six Rupees Only)** was released on dated 20.04.2020 & 09.07.2020 and the balance Amount of **Rs. 2,90,72,726/-(Two Crore Ninety Lakh Seventy-Two Thousand Seven Hundred and Twenty-Six Rupees only)** is to be released as per the new guideline issued by M/o Coal dated 29<sup>th</sup> May 2020.
