ORDER

Release of amount standing in the Escrow Account of MCL Mine.

In pursuance of the Office Memorandum issued by the Ministry of Coal vide No. CPAM-34011/28/2019-CPAM(E-343762) on dated 31st January 2025 (hereinafter called "the OM"), the Nominated Owner has submitted claim application for release of fund from the Escrow Account delineating the work done for the purpose of final mine closure for the respective mine and claim period as per approved Mine Closure Plan. The said claim was duly audited by the Government Institution i.e **CMPDIL, Bhubaneswar** and the inspection was completed by **OSD, CCO, Sambalpur**.

Based on the Audit report of **CMPDIL, Bhubaneswar** and Field Inspection Report of **OSD, CCO, Sambalpur**, the Technical Committee members deliberated on the matter. After deliberation a total amount of **INR Rs.11,43,94,337/- (Eleven Crore Forty Three Lakh Ninety Four Thousand Three Hundred Thirty Seven Rupees only)** will be released out of the claimed amount was recommended for release in terms of the said OM.

On the basis of the recommendation of the Technical Committee, one notice was published and uploaded in the public domain i.e. official website of coal controller Organisation on 03rd, June, 2025. Fifteen days' time was given to any stakeholder for filling objection arising out of the intention to release the amount from the escrow accounts. The said time period of fifteen days expired on 18th, June, 2025 without receiving any objection.

Now, the Coal Controller, on being satisfied that all the requirement to be undertaken by the Nominated Owner has been taken up and on satisfaction of the terms as per Para 3.5.5 of the said OM, hereby **directs that the Amount of Rs. 11,43,94,337/- (Eleven Crore Forty Three Lakh Ninety Four Thousand Three Hundred Thirty Seven Rupees only) to be released** from the respective Escrow Account of the coal mine of MCL as mentioned in **ANNEXURE-I**.

An intimation including closing bank statement in this regard may please be sent to this office after release of the said amount by the Escrow Agent.
